

# BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1

## MINUTES OF SPECIAL MEETING

August 27, 2019

The Bonneville County Fire Protection District No. 1 ("Fire District") held a special meeting on Tuesday, August 27, 2019 convening at the hour of 12:00 o'clock p.m. held at the offices of Nelson Hall Parry Tucker, PLLC, located at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 to open bids relating to the purchase of fire truck..


The meeting was called to order at 12:02 p.m. by commissioner Dan Gubler, acting as chairman. The following were present: Fire District Commissioners Dan Gubler, Ralph Isom and Dave Long. Also present were: Dick Fowler, Fire District Liaison; District accountant Terri gazdick; and, Douglas Nelson, legal counsel.

The commissioners discussed that an Invitation to Bid for a Class A Fire Truck was published in the Post Register, a newspaper of general circulation in the Bonneville County area which notified the public of the opportunity to bid and of this meeting. The commissioners then opened and reviewed the following bids:

1. From the Bridgewater Fire District No. 1, located at 1920 Washington Valley Road, Martinsville, NJ 08836 for the sum of \$190,000.00; and,
2. Ken Garff West Valley Chrysler Jeep Dodge, (Emergency Vehicles Divisions), located at 4175 West 3500 South, West Valley City, Utah 84120 in the sum of \$280,814.00.

Following review and discussion commissioner Ralph Isom made a motion to accept the bid of Bridgewater Fire District No. 1 and to further approve an agreement with Idaho Transport Trucking to transport said vehicle from New Jersey to Idaho Falls, Idaho and deliver the same to the District for a sum not to exceed \$5,600.00. The motion was seconded by commissioner David Long and the same passed unanimously.

The foregoing Minutes of Special Meeting were approved by the unanimous vote of Fire District Commissioners at its regular monthly meeting held September 10, 2019.
