# BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1 Minutes of Regular Meeting held May 14, 2013

The Bonneville County Fire Protection District No. 1 ("Fire District") held its regular monthly meeting of Commissioners on Tuesday the 14<sup>th</sup> day of May, 2013, at the offices of Nelson Hall Parry Tucker, P.A., at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 convening at 12:00 p.m.

## The following were present:

Commissioners Dave Long, Ralph Isom, and Dan Gubler were present, in person. The following were also present: Dick Fowler, District Liaison; Legal Counsel, Douglas R. Nelson; County Planning Administrator Steve Serr; District Accountant, Terri Gazdick and I. F. Fire Chief, Dean Ellis. Also present was Dana Izatt, CPA the appointed outside auditor of the Fire District.

Notice of the time, place and purpose was posted at the Bonneville County Courthouse and at the premises of 490 Memorial Drive, Idaho Falls, Idaho. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

## **DISCUSSION AND ACTIONS**

- 1. <u>Call to Order.</u> The meeting was called to order at 12:10 p.m. by Dan Gubler, acting as Chairman who confirmed that a quorum of Commissioners was present.
- 2. <u>Approval of Minutes.</u> Minutes of the regular meeting of Commissioners held at 12:00 p.m. on April 9, 2013, were reviewed. A motion to approve the minutes was made by Ralph Isom, seconded by Dave Long and the same was unanimously approved. Minutes of the Special Meeting held April 25, 2013 were also reviewed and approved unanimously.
- 3. Approval-Monthly Accountant Report and Bill Authorization. The summary of accounts payable dated May 14, 2013, prepared and submitted by Accountant, Terri Gazdik was reviewed. (copy attached). In addition one bill relating to storage was revised from \$80 to \$880 in order to provide for a full year payment. Mr. Long moved to pay the bills in the total sum of \$10,347.55 and approve the financial report. This motion was seconded by Mr. Isom and approved unanimously.

Time was then turned to Dana Izatt to review the annual audit and the management report for the year ending September 30, 2012 and the auditors governance letter. It was noted that the current years excess revenue was \$102,835.00. However, the auditor pointed out that if the current contract formula with the City of Idaho Falls remains in place that the Fire District is projected to be unable to meet its current obligations from

the expected revenues within 18 to 24 months. The auditor stated that the excess revenue was quite "thin" in relation to total revenue and the projected near term operation costs if the current contract formula is extended. He further stated that the position of the Fire District does not indicate an ability to budget for abnormally large future expenditures for proposed construction of facilities, equipment or staffing expansion.

Following the auditor's presentation Ralph Isom moved to accept the audit and Dave Long seconded the motion. The same was then passed unanimously.

- 4. **Old Business.** No other old business was presented.
- 5. Report by Dick Fowler. District Liason Fowler stated that the new truck should be completed by the end of the following week and the group then discussed possible dispositions of the old truck. Budget issues were briefly discussed. Mr Fowler reported that he had spoked with a realtor regarding the possible purchase of a parcel on York Road subject to platting and a reasonable price.
- 8. Other Business/Reports. Dean Ellis reported regarding a fire in the Cloverdale subdivision which caused approximately \$140,000 in damage. He also responded to general questions regarding the City of Idaho Falls projected fire budget and expenses for the upcoming fiscal year. Steve Serr reported briefly regarding south end area commercial property and the prospect of new development.
- 9. Executive Session. At 1:37 p.m. Ralph Isom moved to adjourn into executive session in acordance with Title 67 of the Idaho Code for the purpose of discussing contract liability and negotiation issues relating to the provision of services by the City of Idaho Falls, A roll call vote was taken and Ralph Isom, Dave Long and Dan Gubler each voted in favor of the resolution, thus approving the same unanimously. At 2:15 p.m. the commissioner adjourned their executive session and upon motion made seconded and unanimously approved reconvened in open session.
- 10. Adjournment. There being no further business to come before the Board of Commissioners at the meeting, a motion was made, seconded and unanimously adopted to adjourn the meeting at 2:18 p.m.
