

**BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1**  
**Minutes of Special Meeting held March 25, 2013**  
**(Bid Opening-Tanker Truck)**

The Bonneville County Fire Protection District No. 1 ("Fire District") held a special meeting of Commissioners on Monday the 25<sup>th</sup> day of March, 2013, at the offices of Nelson Hall Parry Tucker, P.A., at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 for the purpose of opening bids received pursuant to notice and publication for a tanker truck which conforms to certain specifications as shown on the attached Exhibit "A".

The following were present:

Commissioners Dave Long, Ralph Isom, and Dan Gubler, legal counsel Douglas R. Nelson and Garth Dustin, representing Schow Trucking.

Notice of the time, place and purpose was posted at the Bonneville County Courthouse and at the premises of 490 Memorial Drive, Idaho Falls, Idaho. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

**BID OPENING**

1. **Call to Order.** The meeting was called to order at 2:10 p.m. local time by Dan Gubler, acting as Chairman who confirmed that a quorum of Commissioners was present.
2. **Bids.** Two bids were received, opened and reviewed by the Commissioners. One from Grover's All-Wheels, LLC of Rigby, Idaho in the sum of \$69,000 and the second from Southern Fire Service and Sales of Jasper, Georgia in the sum of \$192,500. The bids were discussed. At 3:07 p.m. local time, having received no other bids the Commissioner unanimously approved a resolution to accept the Grover's All-Wheels bid.
3. **Adjournment.** There being no further business to come before the Board of Commissioners at the meeting, a motion was made, seconded and unanimously adopted to adjourn the meeting at 3:180 p.m.

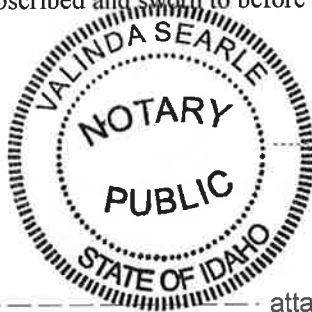

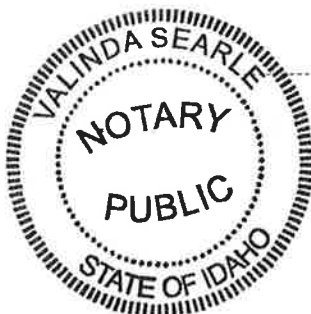

Box 51630, Idaho Falls, Idaho 83405-1620 ("Bid Location"). The bids will immediately thereafter be opened and read aloud in the 2nd floor conference room at the Bid Location.

The bids are invited to provide one (1) tanker fire truck which is a 2007 Kenworth or Peterbilt model year or newer, GVW 33,000 lbs., or greater. Bids must be made in compliance with certain specifications regarding condition, engine size, transmission type, accessories and paint as more specifically stated in certain bid specifications ("Bid Specifications"). ## **BID SPECIFICATIONS**

### **Tanker Fire Truck**

#### **Bonneville County Fire Protection District No. 1**

The Bonneville County Protection Fire District No. 1 ("District") will receive bids until 2:00 p.m. mountain standard time, March 25, 2013 at the offices of Nelson Hall Parry Tucker, P.A., 490 Memorial Drive, Suite 200, P.O. Box 51630, Idaho Falls, Idaho 83405-1620 for the purchase of (1) 2007 Kenworth or Peterbilt model year or newer tanker fire truck, GVW 33,000 lbs., or greater. Bids must be made in compliance with certain specifications regarding condition, engine size, transmission type, accessories and paint as follows:

- (1) ISC Cummins engine with no less than 260 hp and a 3000 RDS Allison automatic transmission.
- (2) Rear axles ratio to be no less than 4.63 with an air ride suspension.
- (3) All aluminum wheels size 22.5
- (4) No less than 10% tread wear on all tire treads.
- (5) Inside components to include a tilt steering wheel, air conditioning, cruise control and an air ride seat.
- (6) A new 2250 gallon Valew RTK-2000-10 water tank with baffles to be mounted with all necessary safety tie downs in accordance with Idaho DOT requirements.
- (7) Warning lights and working lights to be mounted on the rear of the tank with necessary brackets to accommodate rotating or flashing lights with wire tube to be mounted on the rear of the tank for easy access for wiring of rear lights.
- (8) 3 inch pipe threaded on the end to the rear of the tank/truc and a 3 inch threaded outlet at the driver side as determined by the District. Such lines to include ball valves.
- (9) A 10 inch Newton dump valve to be placed at the rear of the tank and wired for an air lock valve for operation from within the cab of the truck.
- (10) Man hole on top of tank with hydrant fill at the rear of the tank with a 3 inch line running to the top of the tank for filling.
- (11) Pump to be a Berkley 3x4 capable of 750 gallons per minute minimum with ability to draft water. Pump must be operable on a pto system from the truck cab and must be of hydraulic type, with reservoir capacity according to specification of the Berkley pump requirements.
- (12) Paint to be safety red on body and white on the cab and tank as per the District's requirements.
