# BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1 Minutes of Regular Meeting held November 11, 2014

The Bonneville County Fire Protection District No. 1 ("Fire District") held its regular monthly meeting of Commissioners on Tuesday the 11<sup>th</sup> day of November, 2014, at the offices of Nelson Hall Parry Tucker, PLLC, at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 convening at 12:05 p.m.

#### The following were present:

Commissioners Dan Gubler, Ralph Isom and Dave Long were present. The following were also present: Fire District Liaison, Dick Fowler; Legal Counsel, Douglas R. Nelson; District accountant Terri Gazdik; and, City of Idaho Falls Fire Chief, Dave Hennaman. Bonneville Planning Administrator, Steve Serr and Ammon Fire Chief, Stacy Hyde were excused.

Notice of the time, place and purpose was posted at the Bonneville County Courthouse and at the premises of 490 Memorial Drive, Idaho Falls, Idaho. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

#### **DISCUSSION AND ACTIONS**

- 1. <u>Call to Order.</u> The meeting was called to order at 12:05 p.m. by Dan Gubler, acting as Chairman who confirmed that a quorum of Commissioners was present.
- **Approval of Minutes.** Minutes of the regular meeting of Commissioners held on October 14, 2014 were reviewed. A motion to approve the minutes was made by Ralph Isom, seconded by Dave Long and the same were unanimously approved.
- 4. Monthly Financial Report and Bill Authorization. The summary of accounts payable dated November 10, 2014, prepared and submitted by Accountant Terri Gazdik was reviewed. Upon motion made, seconded and unanimously passed the report was accepted and authorization payments totaling \$500,830.16. A copy of the report is attached to these minutes. It was discussed that payment of the approved amount will be made by liquidating the Zion's Money Market Fund and the maturity from the Key Bank C.D. which will be rolled into the general checking account.
- 5. Report by Dick Fowler. Dick Fowler reviewed with the commissioners a drawing for an open pit catch basin for the Faust and York road buildings. Discussion regarding drainage and permits followed.

Terri Gazdik reviewed a proposal for the Eagle Ridge Urban Renewal District and its limited impact on the Fire District revenue.

Dick Fowler reviewed the appraisal obtained for the 2008 Dodge truck at \$22,300.00. By motion made, seconded and unanimously adopted the Commissioners approved a resolution declaring the truck as surplus and authorizing a published sale to be reviewed at the noon meeting scheduled for Tuesday, December 9, 2014.

The commissioners discussed current equipment needs and future staffing and possible volunteer fire fighters programs.

- Report by City Fire Chief. City of Idaho Falls Fire Chief Dave Hanneman was introduced to the group. He reviewed his employment history and expressed appreciation to be back in Idaho and have the opportunity to serve the Idaho Falls area. He noted that Idaho Falls has grown in EMS and would like to collaborate with various providers in the area to create a broader network. The group held a general discussion regarding the value of collaboration among area fire fighting groups to improve capacity. Chief Hanneman describe plans for possible re-organization of the City Fire Department using Administrative and Operations departments with battalion commanders. He also discussed the need for a training administrator. He is presently working on job descriptions for the new positions.
- 7. <u>Adjournment</u>. There being no further business to come before the Board of Commissioners at the meeting a motion was made to adjourn and approved unanimously.


