### **Minutes of Special Meeting held April 23, 2025**

The Bonneville County Fire Protection District No. 1 ("Fire District") held a special meeting of Commissioners on Wednesday, the 23<sup>rd</sup> day of April, 2025 at 2137 S Ammon Road, Ammon, ID 83406 in Chief Stacy Hyde's office convening at 5:45 p.m.

The following were present:

Commissioners Ralph Isom (via phone), Derik Nielsen, Tyler Gebbs, Dana Kirkham, and David Long (via phone) were present. District Operations Officer Dick Fowler and Attorney Abigail French (at approximately 5:51 p.m.) were also present.

Notice of the time, place and purpose was posted at premises of 490 Memorial Drive, Idaho Falls, Idaho, as well as the Fire District website. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

### **DISCUSSION AND ACTIONS**

1. **Call to Order**. The meeting was called to order at 5:45 p.m. by Ralph Isom.

At approximately 5:52 p.m., the Executive Session was closed.


