BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1 Minutes of Regular Meeting held April 9, 2013

The Bonneville County Fire Protection District No. 1 ("Fire District") held its regular monthly meeting of Commissioners on Tuesday the 9th day of April, 2013, at the offices of Nelson Hall Parry Tucker, P.A., at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 convening at 12:00 p.m.

The following were present:

Commissioners Dave Long, Ralph Isom, and Dan Gubler were present, in person. The following were also present: Dick Fowler, District Liaison; Legal Counsel, Douglas R. Nelson; County Planning Administrator Steve Serr; and District Accountant, Terri Gazdick. Excused from the meeting was I. F. Fire Chief, Dean Ellis who was away from the area during the time of the meeting.

Notice of the time, place and purpose was posted at the Bonneville County Courthouse and at the premises of 490 Memorial Drive, Idaho Falls, Idaho. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

DISCUSSION AND ACTIONS

- 1. <u>Call to Order.</u> The meeting was called to order at 12:10 p.m. by Dan Gubler, acting as Chairman who confirmed that a quorum of Commissioners was present.
- 2. <u>Approval of Minutes.</u> Minutes of the regular meeting of Commissioners held at 12:00 p.m. on March 12, 2013, were reviewed. A motion to approve the minutes was made by Ralph Isom, seconded by Dave Long and the same was unanimously approved.
- 3. Approval-Monthly Accountant Report and Bill Authorization. The summary of accounts payable dated April 12, 2013, prepared and submitted by Accountant, Terri Gazdik was reviewed. (copy attached). In addition one bill was added to the list of payable to Castle Lake Insurance for Errors & Omissions insurance in the sum of \$3,292.63 Mr. Long moved to pay the bills in the total sum of \$393,915.01and approve the financial report. This motion was seconded by Mr. Isom and approved unanimously.
 - It was also discussed that the Fire District cashed out the TIP account with the Bank of Idaho and moved ½ to Key Bank and the other ½ to the Bank of Idaho to invest in a Certificate of Deposit which accrues interest at .35% per annum.
- 4. Old Business. The commissioners were reminded of a special meeting that will be posted and held on April 25, 2013 to discuss budget issues and set a time for the annual budget hearing.
- 5. Report by Dick Fowler. District Liason Fowler stated that the paint on the new tanker had been discussed with Grover's as they need an ida on how the District wants the paint

to be done. It was decided that Dan Gubler would be in contact with Grover's and let them know the specific desire of the Fire District. It was also mentioned that licence plates for the 2008 Dodge were being ordered as an exempt plate. The commissioners then discussed a one (1) acre lot on 65th South for a possible future fire station. It was determined to offer the sum of \$34,000.00 to purchase the lot provided that the lot is platted and the title is free and clear.

- 8. Other Business.. Steve Serr reported that he visited with Falls Water Company regarding hydrants by the Lincoln School. It was stated that the hydrants need to be raised in order to be fully functional. It was also discussed that Dick Fowler would contact representatives of Bonneville School District 93 to request that a fence be moved because it was too close to the hydrant in the school yard at Lincoln
- 9. <u>No Executive Session.</u> Although on the agenda, the Commissioners did not adjourn into executive session.
- 10. <u>Adjournment</u>. There being no further business to come before the Board of Commissioners at the meeting, a motion was made, seconded and unanimously adopted to adjourn the meeting at 1:25 p.m.
