## BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1 Minutes of Regular Meeting held August 13, 2019

The Bonneville County Fire Protection District No. 1 ("Fire District") held its regular monthly meeting of Commissioners on Tuesday the 13<sup>th</sup> day of August, 2019, at the offices of Nelson Hall Parry Tucker, PLLC, at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 convening at 12:00 p.m.

## The following were present:

Commissioners Dan Gubler, Ralph Isom and Dave Long were present. The following were also present: District Liaison, Dick Fowler; legal counsel, Doug Nelson; Bonneville County Planning Supervisor, Steve Serr; and, City Fire Chief Duane Nelson and Deputy Chief, Dave Coffey. District accountant Terri Gazdik was excused.

Notice of the time, place and purpose was posted at the Bonneville County Courthouse and at the premises of 490 Memorial Drive, Idaho Falls, Idaho. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

### **DISCUSSION AND ACTIONS**

- 1. <u>Call to Order</u>. The meeting was called to order at 12:17 p.m. by Dan Gubler, acting as Chairman.
- 2. <u>Approval of Minutes</u>. Minutes of the regular meeting of Commissioners held on July 9, 2019 were reviewed, and following a motion made by Ralph Isom and seconded by Dave Long, were unanimously approved.
- 3. Monthly Financial Report and Bill Authorization. The summary of accounts payable dated Aust 13, prepared and submitted by Accountant Terri Gazdik was reviewed. Following discussion and upon motion made by Ralph Isom and seconded by Dave Long the report was unanimously approved including a total expenditure of \$7,655.58.
- 4. **Review and Discussion.** District liaison, Richard Fowler, reported and the commissioners discussed the following:
  - a. Wireless internet access has been installed at York Station #7.
  - b. The possibility to pull in a hardline was discussed with some concern being expressed that it may require crossing the street. After further discussion it was unanimously approved to extend the line under the road to the station.
  - c. The commissioners discussed and unanimously approved a motion to install concrete at the west side storage facility for a cost estimated at approximately \$20,000.00.

- d. Dan Gubler reported on the inspection of a 2007 pumper truck located in New Jersey that is expected to be offered to the District in response to a request for bids to provide a Class A fire truck.
- e. Landscaping and possible parking surfaces at the Westside building location.
- f. After discussion the commissioners unanimously approved the publication of a proposed 2019/2020 fiscal year budget of \$2,208,760 to be reviewed at a public hearing to be held August 27, 2019.
- 5. <u>Discussion and Comment from City of Idaho Falls</u>. Deputy Fire Chief Dave Coffey provided and reviewed a summary of the July, 2019 fire calls, a copy of which are attached to these minutes.
- 6. <u>County Report.</u> Steve Serr reported that Bob Poyser, former AREVA Manager, has posted a notice of sale for AREVA's Idaho property. He also indicted that a proposal is pending for the possible approval of a mixed commercial/multifamily/residential development consisting of as many as 400 homes is being consider for 2 subdivision south of the current Melaleuca facility. He questioned whether or not the Fire District may want to comment regarding the location and size of the development.
- 7. <u>Adjournment</u>. There being no further business to come before the Board of Commissioners at the meeting a motion was made to adjourn and approved unanimously at 2:23 p.m.
