Minutes of Special Meeting held February 16, 2026

The Bonneville County Fire Protection District No. 1 (“Fire District”) held a special meeting of Commissioners on Monday, the 16th day of February, 2026, at 12:00 p.m., at Nelson Hall Parry Tucker, PLLC, located at 490 Memorial Drive, Idaho Falls, Idaho 83402.

The following were present:

Commissioners Derik Nielsen (via phone), Dana Kirkham (via phone), and David Long were present. Commissioners John Taylor and Tyler Gebbs were absent. Chief Jon Molbert and Attorney Abigail French were also in attendance.

Notice of the time, place, and purpose was posted at the premises of 2137 S Ammon Rd, Ammon, ID 83406 as well as the Fire District website. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

DISCUSSION AND ACTIONS

1. **Call to Order.** The meeting was called to order at 12:17 p.m. by Chairman Derik Nielsen.
2. **Discussion and possible action to change the 2026 regular meeting date and/or time due to conflict with City of Ammon City Council Meetings.**


Discussion was had on the fact that the Fire District regular meeting was at the same time as the City of Ammon City Council Meetings and that there had been a request by the City of Ammon for the Fire District to change its regular meeting time. After brief discussion, a motion was made by Dana Kirkham to change the regular meeting time from 6:00 p.m. to 6:30 p.m., with the date and location remaining the same. Said motion was seconded by David Long and unanimously approved.

3. **Discussion and possible action to designate/appoint additional representatives to meet with the City of Idaho for purposes of negotiating a possible extension of the Fire Protection Joint Services Agreement By and Between City of Idaho Falls, Idaho and Bonneville County Fire Protection District No. 1.**

After brief discussion, a motion was made to appoint Chairman Derik Nielsen and Fire Chief Jon Molbert to the negotiations team for BCFD1, to join Dana Kirkham in negotiations with the City of Idaho for a possible extension of the Fire Protection Joint Services Agreement. Said motion was made by Derik Nielsen and seconded by David Long and unanimous approved.


