BONNEVILLE COUNTY FIRE PROTECTION DISTRICT NO. 1

Minutes of Regular Meeting held May 8, 2025

The Bonneville County Fire Protection District No. 1 ("Fire District") held its regular monthly meeting of Commissioners on Thursday the 8th day of May, 2025 at the offices of Nelson Hall Parry Tucker, PLLC, at 490 Memorial Drive, Suite 200, Idaho Falls, Idaho 83402 convening at 12:00 p.m. The meeting was broadcast via Zoom with the following Meeting ID No. 828 0482 6311, and Passcode Fire2025.

The following were present:

Commissioners Ralph Isom, Derik Nielsen (via Zoom at 12:02 p.m.), Dana Kirkham, and David Long were present. Commissioner Tyler Gebs was absent. The following were also present: Attorney Abigail French, Accountant Terri Gazdik, District Communications Officer Dick Fowler, Fire Chief Jon Molbert, City of Idaho Falls Fire Department Fire Chief Duane Nelson, Paul Radford (via Zoom at approximately 12:11 p.m.), Beth Lange, Braxton (via Zoom at approximately 12:13 p.m.), Wynn (via Zoom), Jim Telford, Nolan Chadwick, Jason Howard, Ashlee Meyer, and Randy Virgil. Notice of the time, place and purpose was posted at premises of 490 Memorial Drive, Idaho Falls, Idaho, as well as the Fire District website. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

DISCUSSION AND ACTIONS

- 1. Call to Order. The meeting was called to order at 12:00 p.m. by Chairman Ralph Isom.
- 2. Approval of Minutes. Minutes of the regular meeting of Commissioners held April 10, 2025, were reviewed. A motion to accept the regular meeting minutes was made by Derik Nielsen and seconded by David Long. Said motion carried unanimously. Minutes of the special meeting of Commissioners held on April 18, 2025, were reviewed. A motion to accept the special meeting minutes was made by Dana Kirkham and seconded by Derik Nielsen. Said motion carried unanimously. Minutes of the special meeting of Commissioners held on April 23, 2025, were reviewed. A motion to accept said special meeting minutes was made by Dana Kirkham and seconded by Derik Nielson. Said motion carried unanimously.
- 3. <u>Monthly Financial Report and Bill Authorization</u>. The summary of accounts payable dated May 8, 2025, prepared and submitted by Accountant Terri Gazdik, were reviewed with a total expenditure of \$124,153.69. Ms. Gazdik reported on the status of CDs that

were becoming due and noted that at least one needed paperwork updated in order for it to be renewed. Following discussion, a motion was made by Dana Kirkham and seconded by Derik Nielsen and unanimously accepted to approve the total expenditure of \$124,153.69.

- 4. <u>Discussion and Reports.</u> The following items were reviewed and discussed, or actions were taken:
 - a) Operations Report and Negotiation Team Designation. District Operations Officer Dick Fowler gave his monthly report, which included updates on the new fire truck and a potential purchase of real property from Bonneville Joint School District No. 93. The parcel under consideration is located south and east of the current location and is anticipated to be used as a school site within five (5) to ten (10) years. Mr. Fowler also addressed the upcoming union negotiations and the need to designate the Fire District's negotiating team. After discussion, Dana Kirkham made a motion to designate the following individuals as the negotiation team: Dick Fowler, Dana Kirkham, Terri Gazdik (CPA), Chief Jon Molbert, legal counsel, and selected specialists with expertise in relevant areas of negotiation. The motion was seconded by Derik Nielsen and unanimously approved.
 - b) Report from City of Idaho Falls Fire Department. Fire Chief Duane Nelson of the City of Idaho Falls Fire Department was again unable to provide monthly data due to ongoing software issues. He discussed a presentation he had given to the Fire District commissioners the evening prior. Chief Nelson and Dana Kirkham then discussed current dispatch-related concerns. Chief Nelson explained that his department is cross trained in EMS services. Dana Kirkham expressed concern that residents within the Fire District receive only one (1) ambulance in response to calls, whereas City of Idaho Falls residents typically receive two (2). Chief Nelson provided a print-out of response times, which is attached to these minutes. Discussion followed regarding the validity of comparing response times across jurisdictions and whether such comparisons are appropriate.
 - c) Report from Ammon Area Fire Activity. Fire Chief Jon Molbert reported a total of twenty-eight (28) calls during the month, including one (1) structure fire. Chief Molbert noted that the structure fire had been burning for several hours prior to being reported, but that it was extinguished within six (6) minutes of personnel arriving on scene. He estimated approximately \$100,000 in structural damage and \$50,000 in content damage. Chief Molbert also reported two (2) mutual aid calls, three (3) gas leaks, two (2) motor vehicle fires, one (1) outdoor fire, and one (1) downed fire line. Dana Kirkham questioned Chief Molbert regarding response times and requested that he compile and present data to support the development of a working plan, as she does not believe that the residents of the City of Ammon are receiving the same level of service. She emphasized the need to immediate need to create a strategic plan. Chief Nelson concurred. Dana Kirkham also raised concerns about areas in the Rimrock subdivision where construction is occurring, but she believes fire service coverage remains inadequate. Dana Kirkham discussed the potential need to involve county commissioners to address that issue.

- 5. Public Comment. Noland Chadwick, Firefighter with the City of Idaho Falls, stated that while both departments provide service, the Fire District must prioritize what is best for its residents. He emphasized that response time data should drive the decision-making process and expressed that resolving dispatch and EMS inefficiencies, potentially through departmental consolidation, was necessary to improve outcomes.
- 6. <u>Adjournment</u>. There being no further business to come before the Board of Commissioners at the meeting a motion was made to adjourn by Dana Kirkham and seconded by Derik Nielsen with unanimous approval at approximately 12:48 p.m.
