Minutes of Special Meeting/Workshop held May 7, 2025

The Bonneville County Fire Protection District No. 1 ("Fire District") held a special meeting of Commissioners on Wednesday, the 7th of May, 2025 at the fire station located at 2137 S. Ammon Road, Ammon, ID 83406 convening at 6:00 p.m.

The following Commissioners were present:

Ralph Isom, Derik Nielsen, Tyler Gebbs, Dana Kirkham, and David Long were present.

District Operations Officer Dick Fowler was also in attendance and detailed notes of the meeting.

Notice of the time, place and purpose was posted at premises of 490 Memorial Drive, Idaho Falls, Idaho, as well as the Fire District website. A copy of the notice and agenda is attached to these minutes.

It was declared that a Quorum of Commissioners were present and due notice of the meeting had been posted in accordance with law.

DISCUSSION AND ACTIONS

1. **Call to Order**. The meeting was called to order at 6:00 p.m. by Ralph Isom.
2. **Presentation by City of Idaho Falls Fire Chief Duane Nelson**. Chief Nelson presented on behalf of the City of Idaho Falls regarding the proposed expansion of services provided by the Idaho Falls Fire Department under the current Professional Service Agreement. After the presentation, discussion was had regarding feasibility, benefits, and possible concerns regarding expanding the scope of services.
3. **Patron and Community Comments**. An unnamed member of the public commented on the proposal for proximity dispatch, automatic aid, and mutual aid. In response, Chief Nelson stated he was directed by the City of Idaho Falls council to work on a "merger agreement".
4. **Adjournment**. There being no further business to come before the Board of Commissioners at the meeting, a motion was made to adjourn by Derik Nielsen and seconded by David Long with unanimous approval at approximately 7:14 p.m.


